Executive Director's Report presented by Fejt. The Holiday Lights at Mraz was held December 5th, Santa's Special Delivery had nineteen houses signed up for the program. The Polar Express Program had two sessions- 70 participants for each session. GAIA Restaurant in Berwyn hosted refreshments. The Candy Cane Hunt had two hundred participants. The Building and Grounds team have prepped all snow removal equipment. All buildings were rekeyed. The audit season has started. New financial procedures will be taught to all staff. The personnel policy book is currently being reviewed and revised. It will be presented to the board at a later date. The park district worked with the City of Berwyn on the Food Holiday Box program. The fire and burglar alarms for each building will begin to switch over to FSS starting after January 1st, 2022.
