We welcome Taip Beshiri, who started October 30th, 2021 and Kelly Nagle, who started November 22nd, 2021. The Shadow Creek Disc Tournament is November 20th at Proks Park. The Polar Express now has over 100 participants signed up. The pnd has been drained for the winter. Holiday lighting and daffodil planting will be complete this week. The city of Berwyn will be coordinating their Thanksgiving Holiday meals to go at Liberty Center on Thanksgiving day. The City of Berwyn in conjunction with the Berwyn Park District will pack their Holiday Food Boxes in December.
