Minutes of Monthly Board Meeting Berwyn Park District April 19th, 2022 Proksa Park Activity Center

The regular monthly meeting of the Berwyn Park District Board of Commissioners was called to order at 7:02pm by Board President Brian Brock.

Commissioners in attendance: Brian Brock (President), Ana Espinoza, Gretchen Hause Kostelny, Mario Manfredini, and Zachary Taylor.

Staff in attendance: Sandra Fejt (Executive Director), Debbi Gayon (Superintendent of Recreation), and Cindy Hayes (Superintendent of Finance and HR).

Guests: Jerry Sebesta (treasurer).

Agenda: A motion made by Kostelny, seconded by Espinoza to approve the agenda as presented. Motion unanimously carried.

<u>Minutes:</u> A motion made by Manfredini, seconded by Kostelny to approve the minutes of the Regular Board meeting from March 15th, 2022, as presented. Motion unanimously carried.

<u>Public Comments:</u> Dave Smith voiced that he agrees with the disc golf upgrades. Safety is their priority. He would like to see more signage.

<u>Treasurer's Report:</u> The monthly financial report given by Sebesta. The total investments as of March 31st, 2022, is \$2,308,508.08. A motion was made by Espinoza, seconded by Kostelny to approve the monthly financial report, and place it on file for audit. Motion unanimously carried. Sebesta also commented that the second installment of the Cook County tax bills are expected to be late. A motion was made by Kostelny, seconded by Espinoza to approve April's payables \$47,632.43 and March's payroll \$56,827.97 for a total of \$104,460.40. Roll call: Brock-Aye, Espinoza- Aye, Kostelny-Aye, Manfredini- Aye, and Taylor- Aye. Motion carried.

Executive Director's Report presented by Fejt. report in packet. Flowers and trees have been ordered. Roy Diblick donated thirty-five more plants. He also did on the spot training of some garden tools and plant education to several park employees. We are currently interviewing for seasonal maintenance workers. The park District and the Pershing PTO are partnering for the Kaboom playground at Freedom Park. The playground equipment for Sunshine Park has been ordered and is expected to arrive in July. Outdoor soccer has started. The Easter Egg hunt was successful. Two thousand eggs were hidden throughout Proksa Park. Summer Camp registration has begun. We are currently interviewing camp counselor candidates. The Berwyn Public Art Initiative (BPAI) is asking for help from the park district. They are currently losing their spot to display art in the Depot District due to construction. They would like to display some of their pieces in the parks temporarily. Lisa Hernandez has a DCEO set aside for the park district that equals \$168,500. Arbor week starts April 22 and continues through the following week. DEI will be completed by all staff by the end of May.

West Suburban Special Recreation Association (WSSRA): The minutes of the March 15th, 2022, are included in the packet.

<u>Correspondence</u>: Commissioner Taylor received several emails: A community member was asking if the park district would ever think of having a 21+ Zumba program. Another person was asking about a Double Dutch program. Another person, Summer B. was looking for a space on June 18th, 2022, for the Juneteenth Celebration.

<u>Finance:</u> A motion was made by Kostelny, seconded by Espinoza to waive the reading of O-22-01, 2022 Budget and Appropriations Ordinance. Motion unanimously carried. <u>Building and Grounds:</u> report in packet. A motion was made by Espinoza, seconded by Manfredini to waive the reading of R-22-03, Authorizing the Execution of a Community Partnership Agreement for Freedom Park. Motion unanimously approved. A motion was made by Manfredini, seconded by Brock to approve R-22-03, Authorizing the Execution of a Community Partnership Agreement for Freedom Park.
