There is a delay on the Pour-in-Place being installed due to the quarry strike that just recently ended. There are 2 news channels interested in broadcasting the ribbon cutting ceremony. MWRD is delayed on starting their project until September. Roof replacement began on the Activity Center at Proksa. MWRD wis partnering with the park district for Fiesta at Proksa Park on September 10th, 2022. Movie night and smores was at Freedom Park on July 29th. Over 200 people came out for this. Svengoolie made an appearance in Serenity Park. August 18th is the final concert of the summer series. Dead Dog will be playing starting at 7pm.
