ORDINANCE O-20-04 AN ORDINANCE LEVYING TAXES FOR THE BERWYN PARK DISTRICT FOR THE FISCAL YEAR 2020

WHEREAS, on the 17th day of March, 2020, the Board of Commissioners of Berwyn Park District passed the Annual Budget and Appropriation Ordinance of said District for the fiscal year beginning January 1, 2020, and ending December 31, 2020;

WHEREAS, on the 17th day of March, 2020, the said Ordinance was duly signed and approved by the President and the Secretary of the Board of Commissioners;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Berwyn Park District:

Section One

That, exclusive of any and all taxes authorized by acts which by their terms provide that such taxes shall be in addition to taxes for general purposes, the sum of **ONE MILLION NINE HUNDRED FIFTY SEVEN THOUSAND NINETY EIGHT AND 00/100 (\$1,957,098.00)** is hereby levied and assessed for the fiscal year beginning January 1, 2020, and ending December 31, 2020, for general corporate purposes upon all property subject to taxation within the Berwyn Park District at the full fair cash value as the same is equalized or assessed by the Department of Revenue of the State of Illinois for State and County purposes.

Section Two

Hereinafter set forth under the column entitled "Amount to Be Raised by Taxation" is the specific amount hereby levied for each object and purpose.

This ordinance shall be in full force and effect from and after its passage, and as provided by law.
